- Case Study: The role of transnational organized crime syndicates in the illegal ivory trade in East and Central Africa.

Module 2: Field Patrol and Tactical Operations

- Navigation and bushcraft using GPS and maps.
- Patrol planning, surveillance, and ambush strategies.
- Arrest and restraint protocols, and use of force continuum.
- Case Study: Successful interdiction of a rhino poaching syndicate in South Africa using a coordinated tactical response.

Module 3: Wildlife Crime Scene Investigation and Forensics

- Securing and documenting a wildlife crime scene.
- Collecting and preserving evidence (e.g., DNA, ballistics, tracks).
- Chain of custody and its importance in legal proceedings.
- Basic **wildlife forensics** for species identification and origin tracing.
- Case Study: The use of genetic profiling to link seized pangolin scales to a specific source population.

Module 4: Intelligence Gathering and Analysis

- Developing human intelligence (**HUMINT**) networks within local communities.
- Utilizing open-source intelligence (**OSINT**) and social media monitoring.

- Case Study: The use of aerial drone surveillance to locate and deter poachers in a remote protected area in Sumatra.
